Scams and the Elderly

Our elderly population have worked all their lives to build up “nest eggs”, to own their own homes, and to obtain excellent credit. These hard-working people were raised to be trusting and polite, and often have difficulty saying “no”. Unfortunately, this makes them very attractive to scam and con artists.

Unfortunately, these scams are on the rise and the easiest victims are senior citizens. They do not hang up the phone, they do not say “no”, and they are susceptible to products promising increased cognitive function, virility, physical conditioning, and cancer cures. They are being promised a long and fruitful life. They are poor witnesses if questioned and often do not report the crime, as they are ashamed or worried they are not able to take care of themselves.

The top 10 financial scams targeting our elderly are:

- 1) Medicare/Health Insurance scams - they claim to be a Medicare representative to obtain personal information.
- 2) Counterfeit prescription drugs - they operate on the internet and offer better prices on specialized medications.
- 3) Funeral and Cemetery scams - scammers attend funeral services to obtain personal information from the grieving spouse, or the funeral home adds unnecessary charges to the funeral.
- 4) Fraudulent anti-aging products - everyone wants to look younger than they are.
- 5) Telemarketing/phone scams - they promise products that will not be sent and leave no paper trail. Fake charities are often named and money is solicited for a good cause. Another ploy is telling the victim their loved one is injured and in the hospital, and needs money sent right away.
- 6) Internet fraud - pop-up browsers are notorious for simulating virus-scanning software and asking that the software to be downloaded for protection, enabling the con artist to access personal information on the user's computer.
- 7) Investment schemes - pyramid schemes, fables of a Nigerian prince looking for a partner to claim inheritance money, etc.
- 8) Homeowner/Reverse Mortgage schemes - official-looking letters are sent stating that the property has been assessed and property taxes have increased. The letter goes on to state that, for a fee, of course, the property could be re-assessed and the new tax burden eased.
- 9) Sweepstakes and Lottery scams - you have won a sweepstakes but first you must send money to unlock the prize, often requiring a check from a personal bank account (more information obtained).
- 10) The Grandparent Scam - the scammer will pretend to be a grandchild, the senior gives the name, and the scammer can establish a fake identity with the new information.

It is extremely sad that these vulnerable and trusting people can be targeted so easily and so readily. How can we help? Listen to your loved one. Never allow the senior to give out personal information such as banking, credit card, or social security numbers over the phone. If a salesperson refuses to give the company address and telephone number, do not do business with them. If someone from a “Government Agency” calls demanding money, ask for a certified letter. One of the largest current scams is that you owe money to the IRS. The IRS will never call you on the phone; they will only send you a certified letter in the mail with instructions.

Let's protect our seniors and help them hold on to the monies and properties they worked so hard to establish. Listen to what your loved one tells you about phone calls. Look at what kind of mailings are being received, and offer to help separate the scams from the legitimate letters.


