

What type of care is most appropriate?

Everything was fine until my husband fell. Now we are confused as to what type of care he needs, and what type of continuing care he may need after his recovery. This article will help to educate on the different types of care and which type will best fit an individual situation.

Example #1

Kay is in her 60s, with no health issues, and she lives in a ranch-style home with her spouse. She recently fell and broke her hip. Rehabilitation Therapy in a center will provide the occupational, physical and speech therapy to help Kay return to her home.

Example #2

Bob is 85 years old, and still lives at home. Bob now needs help with lifting heavy objects, vacuuming and cleaning the bathtub. The best type of care for Bob would be Home Care, which provides care in his own home. Bob can remain independent, but receives a little bit of help.

Example #3

Helen just lost her spouse and is now contemplating selling her home. At 74, she is in good shape and wants to remain independent. An Independent Living community will offer maintenance-free living

while allowing her to maintain her active lifestyle.

Example #4

Ken is 90. He has some physical challenges due to his Parkinson's diagnosis. He will need some assistance with his activities of daily living, but is functioning fine cognitively. Assisted Living would be the perfect setting for Ken to receive the care he needs without impacting his ability to do other activities.

Example #5

Linda had a heart attack and is no longer able to feed herself or get to the toilet without the help of two strong care providers. She needs someone to check on her throughout the day to make sure her needs are taken care of. Skilled Nursing would provide the level of care she needs to live comfortably.

Example #6

Tom is in his 80s and was recently diagnosed with advancing dementia. He is not oriented to time and place, has difficulty expressing his needs, and can make decisions that could cause serious safety issues. Memory Care would be the best option for providing the personal care and stimulation he needs while also providing a safe environment.



Spotlight on a Resident

Eric Cahn recently moved to Independent Living, Star Vista Village. He will be speaking about his life before moving to ESMRC at 10:30 am Wednesday, Oct. 23, in the Chapel, multi-purpose room.

He is a survivor of the Holocaust. He is also a published author, Maybe Tomorrow: A Hidden Child of the Holocaust.

In his words, here is how his life began:

I was born March 29, 1938, in Mannheim, Germany. My parents were Julius and Johanna Cahn. My father owned a butcher shop. My mother was a housekeeper.

They did experience anti-Semitism and on Kristallnacht spent the night down on the Rhine River with me in a baby carriage. I had

a younger sister who was born on June 4, 1940. (She died on Aug. 19, 2007.)

On October 22, 1940, my family, along with several hundred other Jews, was taken out of our home, taken by truck to the nearby railroad station, and then taken by freight train, like animals, from Mannheim, Germany, to the southern part of France to the holding camp, Camp Gurs. We managed to survive there until August 1942.

My younger sister and I were rescued from Camp Gurs and were separated from each other. My parents had made the difficult decision to give us up so we could be rescued. Had they not done that, I would have wound up in Auschwitz with them and, at the



age of four, I would have died.
