WHAT WE COVER

The following causes of loss are covered by your Fortress Protection Plan:

- Aircraft or Vehicles
- Burglary & Forced Entry

WHAT WE DON'T COVER

The following items are not covered by your Fortress Protection Plan:

- Accounts, Bills, Currency, Data, Documents, Deeds, Evidences Of Debt, Money, Notes, Records, Securities or Stamps
- Aircraft
- Animals, Birds or Fish
- Contraband or Other Property Held for, or in the Course of, Illegal Transportation, Sale or Trade
- Firearms
- Furs, Fur Garments and Garments Trimmed with Fur
- Jewelry, Watches, Precious or Semiprecious Stones, Bullion, Gold, Goldware, Gold-Plated Ware, Silver, Silverware, Platinum or Other Precious Metals or Alloys
- Photographic Equipment
- Property Stored Outside of Your Storage Unit

SET YOURSELF UP FOR SUCCESS

Store & Protect Your Property Properly:

- Place boxes on pallets, skids or 2 x 4s.
- Cover property with plastic sheeting or drop cloths.
- Store electronics in the rear of your unit.
- Don't store valuables or sensitive materials – like money, jewelry, cameras, etc. – in your unit.
- Keep a detailed inventory of your items and back it up with photographs.
- Always lock your storage unit.

- Report break-ins or foul play to your local police.
- Take photos.
- Don't discard damaged property.
- Protect remaining property from further damage.
- Keep your lock — even if it's been damaged.
