The Springs Living Chief Operating Officer Brenda Connelly Inducted Into McKnight's Women of Distinction Hall of Honor

As chief operating officer, Connelly led the company-wide operational COVID response while working closely with statewide organizations, including serving on the Long-Term Care COVID Forum in Oregon and the Montana governor's COVID Advisory Task Force. In 2021, she led community teams to regain six of the eight percent occupancy lost during the pandemic, while concurrently achieving and exceeding lease-up targets for three communities that opened at the start of the pandemic.

Connelly holds a master's degree in quantitative management – health analytics from Duke University's Fuqua School of Business. She also has a Bachelor of Science in nursing from North Dakota State University. Connelly serves on the Oregon Health Care Association Quality and Compliance Council. She received a Special Services Award from Oregon Health Care Association in 2021.
