Letter from Administrator

I hope that you are enjoying the fact that we have resumed the newsletter. We hope to expand to include more information and we are definitely interested in hearing from you as to what information or content you would like to see us include.

I thought this would be a good time to recap our transportation policy, as questions have come up recently.

Geneva Lake Manor will transport residents in need of transportation to medical appointments as the facility van is available. The transports will be billed to all parties responsible for the bill. This includes all private pay and Medicaid transport that is not medically necessary as well as Medicare transports that do not meet criteria of ambulance transport.

Please note that

- 1. The van is not available on Thursdays, as it is used by the activities department.
- 2. All resident families will be contacted for appointments and families will need to transport all residents that are physically able to be transported via car or family vehicle.
- 3. Any resident that is able to transport via a vehicle, but family is unable to provide transports, we ask that you make arrangements with VIP, Senior Cab, Senior on the Go. or Wal to Wal. Numbers

available on request.

- 4. If the resident is unable to transport via car, and needs wheelchair transport, the facility will set up transport with the facility van.
- 5. Any medically related transport requests must be made 72 hours prior to the date of transport unless it is an emergency. Any nonmedically related transportation requests must be made at least one week prior to the date of transport. Geneva Lake Manor cannot guarantee the facility van will be available for all transportation requests. Medically related transportation will take precedent to nonmedically related requests.
- 6. Residents with an activated POA or Guardian must be accompanied by POA or approved person to all appointments.

Base rate \$25 (includes the first 5 miles)

- Every mile after is \$2.50
- Wait time- \$10/30 minutes
- After hours 6am-6pm and Saturday and Sundayan additional \$35
