

## Lewis Privacy Policy

This Privacy Policy is effective as of July 1, 2021.

### Our Commitment to Privacy

We use industry standard safeguards to protect the confidentiality of personal information we collect from visitors to this Web site. Personal information collected is accessible only by designated staff or agents of our organization who are also bound to this statement. It is important to recognize that “perfect security” does not exist on the Internet. This statement is provided to clarify our commitment to protecting the security of the personal information you provide.

When you register on our site, we may ask for information such as your name, email address, postal address, zip code, telephone, gender, personal interests and preferences of our products and services. We do not collect or maintain information from those known to be under the age of thirteen. We will not contact children under age thirteen without a parent’s permission. In addition to the information provided by Web site visitors, our computers automatically receive and record information from your Internet browser, including your IP address, cookie information, and the pages you request.

### How We Use and Disclose Your Information

We use information you provide on an aggregated basis to do such things as operate our site, enhance our site, and to better understand the profile of our online audience. Please note that the CCPA limits these rights by, for example, prohibiting us from providing certain sensitive information in response to an access request and limiting the circumstances in which we must comply with a deletion request. If we deny your request, we will communicate our decision to you.

## Important Information for California Residents

This section applies to California residents. - **Deletion.** You can ask us to delete the Personal Information that we have collected from you.

- **Opt-out of sales.** If we sell your Personal Information, you can opt out. In addition, if you direct us not to sell your Personal Information, we will consider it a request pursuant to California’s “Shine the Light” law to stop sharing your personal information covered by that law with third parties for their direct marketing purposes.
- **Opt-in.** If we know that you are younger than sixteen years old, we will ask for your permission (if you are younger than thirteen years old, we will seek your parent’s/guardian’s permission) to sell your Personal Information before we do so.
- **Nondiscrimination.** You are entitled to exercise the rights described above free from discrimination. This means that we will not penalize you for exercising your rights by taking actions such as denying you services; increasing the price/rate of services; decreasing service quality; or suggesting that we may penalize you as described above for exercising your rights.
