
COOPERATIVES: A UNIQUE FORM OF OWNERSHIP AT A GLANCE

MEMBERSHIP PURCHASE

The purchase of a share provides a membership in the cooperative, one share per home. There are two primary costs associated with membership: the share price and the monthly fee.

The share price is the purchase price and is set at 40%-60% of the share value, which keeps cooperative homes reasonably priced compared to single family homes, townhomes, or condominiums priced at full market value.

MONTHLY FEE

The monthly fee includes a pro-rata share of the cooperative's master mortgage, property taxes, reserves, and building insurance. Other operating costs, such as internal and external maintenance, gas heat, water, sewer, garbage removal, bulk rate TV and internet service, and secured underground parking are also included. Electricity, phone, and homeowners insurance are the member's responsibility.
