PERSONAL INFORMATION WE COLLECT

We collect personal information from this Website in order to provide information, facilitate communication, transactions, and services with you and between you and any third party service providers, and to help us better understand how we can assist you in your search for housing, or to obtain services as a resident in the rental property you occupy.

The different types of personal information we collect will depend upon what we will need in order to provide you with the particular product or service you are interested in. The information requested on our registration form includes some or all of the following personal information:

- General information (e.g., your name, address, email address, telephone number, date of birth, and other types of demographic information including gender, age, and marital status)
- Information collected to create an account (e.g., user name and password),
- Information that you provide voluntarily in connection with your use of any interactive tools or resources on the Website relating to finding, leasing, or accessing services for a rental property, including submission of an inquiry, contact or schedule a visit form,
- Lease application or related payment information, which in addition to the general
 information listed above, may include information such as your Social Security number,
 driver's license number, government identification documents, personal image of yourself,
 present and prior postal addresses, , monthly rent paid at previous residences, employers,
 job titles, occupation, income, references, emergency contact information and information
 about your pets and vehicles, including license plate numbers
- Payment-related information, such as credit or debit card information, bank account information and routing numbers, and automated clearing house (ACH) information
- In connection with your submission of service requests, or other communications with the Property Management Company, its agents or third party service providers, or the nature of work requested
- In connection with your use of any interactive educational or informational resources provided to residents through the Website
- In any postings you make on any community page or otherwise on the Website or in any emails that you send to us
- In connection with your use or purchase of any other services or products provided by the Website or by any third party service providers,

USAGE TRACKING: USE OF IP ADDRESSES
