WHEN TO PAY YOUR BILL

DUE DATE: ALL CHARGES ARE DUE WITHIN THIRTY (30) DAYS OF THE BILL DATE. PAYMENTS RECEIVED (AT CITY HALL) AFTER THE DUE DATE ARE SUBJECT TO ONE PERCENT (1%) INTEREST PER MONTH UNTIL PAID.

FAILURE TO PAY THIS BILL WITHIN SIXTY (60) DAYS OF THE BILL DATE MAY RESULT IN THE DISCONTINUANCE OF SERVICE.

SECTION 25-2-2 OF THE FREDERICK CITY CODE PROVIDES FOR ADDITIONAL CHARGES TO RESTORE SERVICES SUSPENDED FOR FAILURE TO PAY. SERVICE CHARGES SHALL BE A FIRST LIEN AGAINST SAID PROPERTY.

OTHER IMPORTANT INFORMATION

RATE SCHEDULES: COPIES OF OUR COMPLETE RATE SCHEDULES ARE AVAILABLE ONLINE AT WWW.CITYOFFREDERICKMD.GOV. THE CITY CHARGE FOR SEWER SERVICE PROVIDED BY THE CITY TO USERS WITHIN THE CITY IS ONE HUNDRED FORTY PERCENT (140%) OF THE CHARGE FOR WATER.

ACCOUNT NAMES: WATER AND SEWER ACCOUNTS ARE MAINTAINED BY THE NAME OF THE PROPERTY OWNER. ACCOUNT NAMES ARE CHANGED WHEN A PROPERTY IS TRANSFERRED.

RETURNED PAYMENT POLICY: A RETURNED PAYMENT FEE WILL BE CHARGED IF A PAYMENT IS RETURNED BY YOUR BANK FOR ANY REASON.

ROUND-UP PROGRAM - THE CITY OF FREDERICK HAS APPROVED A PROGRAM THAT WILL ALLOW CUSTOMERS TO ROUND THEIR CURRENT BILL CHARGES TO THE NEXT HIGHER WHOLE DOLLAR AMOUNT AND TO HAVE THAT ROUNDED AMOUNT PLACED IN AN ACCOUNT TO ASSIST HOMEOWNERS WHO ARE HAVING DIFFICULTY IN PAYING THEIR WATER & SEWER BILL.
