4. Children's Privacy

5. Cookies

We use session and persistent cookies to improve navigation, login convenience, and user experience. You can manage cookie preferences in your browser settings.

6. Third Party Analytics Tools

We use tools such as Google Analytics to gather aggregated information about visitor behavior, device type, and geolocation to improve user experience and marketing performance.

7. Third Party Advertising Tools
